

Road use charge Czech Republic

Time-related toll for the use of toll roads has been in effect in the Czech Republic since 1995. After 25 years, 2020 is the final year where drivers on Czech motorways will use traditional paper stickers. The State Fund for Transport Infrastructure in cooperation with the Ministry of Transport will launch the electronic vignette system on January 1, 2021.

Road use charge

All motor vehicles with at least four wheels and maximum permissible weight up to 3.5 tonnes have an obligation to purchase an electronic vignette. The obligation does not include towed vehicles, motorcycles and exempt vehicles.

Road can be used only after payment of the time-related toll.

The electronic vignette does not have to be purchased at the beginning of January: 1-year vignettes from 2020 are valid until January 31, 2021.

Types and prices of Electronic Vignettes

| Type | Standard Price | Eco Price * <i>vehicles fuelled by natural gas or biomethane.</i> |
|---------|----------------|--|
| 1 year | 1 500 CZK | 750 CZK |
| 30 days | 440 CZK | 220 CZK |
| 10 days | 310 CZK | 155 CZK |

* LPG-powered vehicles are not given Eco prices.

All types of electronic vignettes can have the beginning of their validity delayed by up to three months.

Vehicles registered abroad exempted after submitting notices

Vehicles powered by electricity, hydrogen, or a hybrid fuel system (provided CO₂ emissions do not exceed 50 g/km). Exemption notice can be downloaded on websites: <https://edalnice.cz/en/exempt-vehicles/>

Fines

- A driver found to be on a toll road without a valid electronic vignette (without being exempt) faces a fine of up to CZK 20,000.

- Controls will also check for abuse of exemptions. If a physical or legal entity submits an exemption announcement without have the right to the exemption, the fine can reach up to CZK 100,000. If a car is eligible for exemption, but the driver didn't submit a notice despite the law demanding it, the fine can reach up to CZK 5,000. The same fine can be levied on those who do not announce an end to the right to the exemption within 10 days.
