































16 Associations demand an agreement on Mobility Package

Following three trilogue meetings between EP, Council and European Commission on the finalisation of parts of the Mobility Package on cabotage, driving and rest time and posting of workers, 16 road haulage associations representing more than 65.000 member companies demand from the involved parties to finally find an agreement two and half years after the Commission proposals.

The EU internal market for road transport urgently needs new and harmonized rules to face today's challenges and demands. Patchwork of rules has to come to an end. It is the future of the European road haulage industry which is at stake for the next 10 years to come.

Despite different points of view on certain topics within the Mobility Package, an agreement appears very close, also including solutions around the organisation of driving and rest time the return of the truck and cabotage. The signing associations therefore ask for clarity and uniformity in the EU legislation for which the Mobility Package paves the way.

The sector has made important concessions in the course of the negotiations and in return demands to finally see the outcome. The road haulage sector would not understand a failure at this stage and expects flexibilty from all actors in the trilogue to make out of the Mobility Package a success.
